**Staff Reports**

- a. Discussion: Jesse mentioned that he was happy to see Madison Harris back as the Recreation Coordinator. He mentioned that she has done a good job in the time he has seen her at SJHS and at the baseball/softball fields.

**Old Business**

- a. 2025-26 Budget:
  - i. Discussion: Alex Mock mentioned that he made an adjustment to the budget but it moved money from the reserved account to a lesser amount since there was a mistake in the income for Women's Volleyball. No other changes were made.

- b. Executive Director Inquiries on all bank transactions, balances & pledging information
  - i. Discussion: Alex made a recommendation to the board that he be allowed to see all the accounts including bank transactions, balances & pledging information. It was noted this was out of date procedure as Rich was the one able to see those being the business manager. Alex would be able to see the information but there would be no account access to move money

b. DJ Dearcorn
